#### **Media and Other Activities:**

8/13 - Fish & Wildlife Commission Florida Black Bear Hunt Public Hearing in Havana, FL, just outside of Tallahassee- members of Sierra Club, Bear Defenders, Animal Rights of Central Florida (ARCF), One Protest, Speak Up Wekiva, Bear Warriors, FVA and many others joined in to speak out against the hunt. Thanks to Sierra Club for providing free buses for activists who joined in from several areas around Florida to speak for our cherished black bears. Despite many well-informed activists and members of the public speaking out about the horrific aspects of the hunt, the FWC chose not to listen to 81% of Floridians who opposed the bear hunt. Tragically the FWC voted to proceed with the hunt and not only allowed very cruel and archaic methods, such as baiting, bow and arrows, hounding and more, but made it easy for the FWC to have future hunts without requiring public

To some people, Thanksgiving in the present is little more than the starting gun of the holiday shopping season, and the pilgrims and Native Americans of the First Thanksgiving serve only as decoration around the table and in shop windows.

So, I stopped observing this holiday of no meaning to me. Just a few years ago, I decided to use this holiday with meaning; to THANK people in my life that I respect and who had been meaningful in the betterment of my life, and my life's purpose such as a special doctor whose genuine concern and advice to me had nothing to do with his specialty. That is what I am doing this Thanksgiving; Thanking all the people at FVA, other organizations I work with, and individuals I know who give their precious time, compassion and \$\$ to help the animals that so many misuse & exploit. Now this day has meaning to me!

I have done some searching on how this holiday came about. Thanksgiving Day has its origins in early harvest celebrations and is commonly associated with a 1621 feast shared between the Pilgrims and the Wampanoag people (native Americans) in Plymouth, Massachusetts. Though this day is now commonly associated with eating turkey, no turkey was eaten at this first Thanksgiving celebration.

To the Native Americans, however, who had their land, language, and culture systematically taken from them, Thanksgiving is understood as celebrating the English conquest and outright theft of lands they had occupied for thousands of years. Native Americans in the present day, whether through public displays or private rituals, observe the day quite differently from the descendants of the immigrants who arrived in North America in the 17th century.

# SPCA President pleads guilty to Animal Cruelty

FOX 13 reports that on Friday, August 29, 2025, the SPCA of Tampa Bay has pleaded guilty to animal cruelty charges stemmed from an incident that dates back to July 2025, involving a male pig named Waddles.

As reported by FOX 13, Waddles was in the care of SPCA of Tampa Bay when a video that went viral on Tik Tok showed him "with burned and blistered skin."

"Advocates accused the SPCA of leaving Waddles out in the scorching hot sun, which caused his skin to burn, crack and bleed," reported FOX 13.

At the time, following the allegations, Pinellas County Animal Services cited the SPCA of Tampa Bay for animal cruelty. According to FOX 13, **Martha Boden**, the SPCA president, told the news agency that when Waddles arrived at their facility, he was already suffering from "preexisting skin issues." Spectrum News reports that Waddles was surrendered by his guardians on July 10, 2025.

Boden went on to tell FOX 13 that they provided proper housing, food, enrichment and veterinary care and showed the reporter "the pasture and barn they had for Waddles and the mudholes they had created for him."


Reportedly, BODEN told FOX 13: "We feel really good about the way we were able to help him stabilize." From Boden's standpoint the information released by the public has created a false narrative of Waddles' care, making the allegations false and said the SPCA of Tampa Bay intended to fight the citations. However, court records show that the SPCA of Tampa Bay entered a guilty plea.

The nonprofit Pork Butt Pastures Rescue, run by Kelly Dill, took Waddles from the SPCA and happily announced that he's now made a full recovery.

Kelly told FOX 13 she saw Waddles listed on the SPCA's website and when she went to visit him she was shocked by his condition. Kelly explained: "When I got there to see him, I was absolutely horrified at the condition he was in. He was raw and bloody, with no water — just out in the hot sun, roasting. If I hadn't taken him, it would've been death for sure — within 24 to 48 hours, he would no longer be here."

According to FOX 13, a police report about animal cruelty has also been filed with the Largo Police Department.

## Bear Warriors Lawsuit against FWC Bear Hunt Update



August 13, 2025. the Sierra Club chartered three large buses to take activists from Tampa, Orlando and Jacksonville to the Fish & Wildlife Commission (FWC) meeting in Havana, FL. This meeting was to allow the commissioners the last opportunity to hear public opinion before casting their vote. Just like other meetings, the FWC allowed a few officials who were in favor of the hunt, to talk as long as they wanted. After that, the 165 people on the list were allowed to speak for only 1 minute. An overwhelming majority gave very good solutions to allow the bears to exist without threat of being killed. Hunters only bragged how they were able to kill bears. The previous hunt in 2015 ended in only two days due to the massive numbers of bears killed. After approximately 3 hours of opinions, the FWC commissioners cast their vote in favor of the hunt. A few days later, Bear Warriors submitted their petition which is a precursor to the lawsuit to block the hunt.

September 10, 2025: Bear Warriors United has withdrawn its lawsuit seeking to block the state's planned black bear hunt but intends to take its battle to another court as the state prepares to accept hunting permit applications.

### Wildlife Trapping

The Florida Wildlife Commission is considering changes to its current rules on trapping. It has been over 50 years since the FWC updated its trapping rules and we were told in 2023 its intent is to modernize the state's rules and make them more humane.

The most alarming change the FWC is pushing is to remove the "special use" permit requirement for steel traps, including body crushing and leg/foot hold traps. If this requirement is removed there will be no restrictions on the antiquated and barbaric traps that maim and kill our wildlife in the most inhumane way. If the change is passed any member of the public could legally use a steel leg hold trap.

The FWC prohibited steel traps in 1972 with encouragement from the 'dog' hunters claiming their dogs were getting caught in the traps. They later added legal use of the traps with a "special use" permit issued by the FWC. The proposed changes keep trap check time at 24 hours.

The trapping rule changes proposed by FWC staff will be presented to the FWC Commission at their next meeting in Clewiston FL on Nov. 5th-6th. I have served as a member of the FWC's Technical Assistance Group (TAG) on trapping for two years and continue to provide input on rule changes. ### Tribute to Rob Lorei, WMNF

We are so saddened with the passing of Rob Lorei, a pioneer in radio talk shows. Rob helped start WMNF and not only developed it into a great station, but he also opened doors for many other causes and groups

Back in the 1980's, in the very early days of FVA and even WMNF, Rob reached out to FVA to interview us about our group and our events. We did a show about animals used in research and discussed our first campaign about ending the use of primates in research. He was extremely gracious and patient in helping us (me) get comfortable with the media in the early days and brought local animal rights issues to the forefront in this area.

Doing his show was a springboard for FVA that led us to doing TV interviews and even to develop "Animal Rights Forum" our own TV program on Jones Intercable Public Access Center. Programs were aired on Paragon in the 80's and 90"s.

Rob helped many others get a start on radio and on WMNF programs, including Duncan Strauss, host of the popular show Talking Animals (TA), who speaks fondly of him. "He was a bright, lovely man and enormously influential in the Tampa Bay area, and beyond. Personally, as I noted in my



on-air remembrance, when I was looking for a Florida home for TA as my family was gearing up to move from California, he gave me and a TA a tryout. It went really well, and he put the show on the WMNF broadcast schedule. That was 20 years ago." FVA is forever grateful for Rob taking a chance with amazing shows like Talking Animals. Duncan has brought a plethora of animal topics and personalities to share with our community.

Rob moved into a bigger limelight when he joined WEDU PBS public station in 1995 to host the show "Florida This Week," Tampa's longest-running public affairs program. The popular show still runs and includes roundtable discussions with guests that include political leaders, officials, and journalists.

Rob Lorei, who championed community radio and independent journalism, died of cancer on 8/17/25. Even as he faced his final challenge, he was brave and did so with grace and acceptance. We love WMNF and greatly appreciate all Rob did to support many causes including helping a fledgling animal rights group from its inception and bringing our important animal issues to the forefront.

of hunters and pro-developers. This needs to change by

including members who have a background with wildlife and environment protection, scientists who have the knowledge to do so, and members of Florida animal protection organizations. 8/2 – Unitarian Universalist Church, St. Petersburg- A group gathered to learn how to join in efforts to help stop the black bear hunt. They listened to a presentation on the Florida black bear issues, including the proposed hunt, and some of the

- © Jan 2025: Laws in Colorado and Michigan that ban the production and sale of eggs from caged hens came into force A public policy approach that produces strong legislation is crucial to Humane World's campaign to end the cruel practice of confining hens in battery cages, wire cages that are so small that the birds trapped inside them can't even spread their wings
- © Jan 2025: Massachusetts law banned the use of elephants, big cats, primates, giraffes and bears in traveling shows This success was the result of a decades-long Humane World campaign to address the cruel display of animals in such contexts.
- © Jan 2025: Minnesota, a new fur farming law is also now in force, requiring fur farms to register with the state This will increase transparency concerning the scale of this industry there, and the law allows the state to conduct inspections of fur farms and mandates that the Department of Natural Resources perform disease testing at these facilities.
- © Sep 2025: California lawmakers pass bill that will bar some popular puppy sellers SACRAMENTO State lawmakers approved Assembly Bill 519 that would ban online pet dealer websites and shadowy middlemen who pose as local breeders from selling dogs to California consumers the latest move to curtail the pipeline from out-of-state puppy mills. California became the first state in the nation with a 2019 law to bar pet stores from selling commercially bred dogs. That retail ban, however, did not apply to online pet sales, which grew rapidly during the COVID-19 pandemic emergency.
- © Sep 2025: The massive stakes of the Trump administration's plans to end animal testing The agency had set deadlines under President Trump in 2019 to reduce animal testing 20 percent by 2025. They will reallocate funds away from animal experimentation and toward cutting edge alternatives.
